And did you know Congressmen Olver and Neal have cosponsored HR 3207, the Amateur Radio Volunteer Protection Act of 1996? So, our presence (at large, at least) is acknowleged. Let's keep our responsible image shining and well known by a couple of hundred reminders. Stress our public

service (use the word free - legislators love it) and emergency preparedness (you do have an alternate power supply other than your 2nd HT battery, don't you?). 

#### TECH TIP #3

Floating is not the same as flying!!! If your shack is on the second floor of a home or apartment complex, you may not be able to get a good ground for your rig. Also, newer homes use PVC piping instead of copper, so even if you are on the ground floor, the cold water pipe you may have hooked into may not be continuous to ground. If you are having problems getting a good ground, try making your connection directly to the water meter section of your service. If you are on a second or third floor (or higher), counterpoises can be used (at least 1 for each band you want to transmit on), or "artificial grounds" can be purchased. REMEM-BER - COUNTERPOISES ARE PART OF THE ANTENNA SYSTEM - don't place them where you or anyone else can contact them!
