Our annual Auction is back to it's traditional time in November, and should prove to be another great one! Don't be surprised if it proves to be a little tight in the church, as we have advertised it in all the major magazines. Get there early! Doors open at 7:00 p.m., the auction starts at 7:30!

HURRICANE FRAN

Packing winds in excess of 105 miles per hour, Hurricane Fran hit the United States along the Carolina shoreline near Cape Fear at about 10 p.m. Eastern time on Thursday, September 5. According to the Reuters news agency, ham radio operators in Myrtle Beach, South Carolina, clocked winds in excess of 120 miles per hour in their reports to the National Weather Service. The Storm submerged beach towns, ripped steeples off churches and snapped trees into sticks as it roared through the Carolinas. At least a dozen people were left dead in its wake.

According to news reports, ham radio was a vital link in coordinating all aspects of this emergency. When the Shenandoah National park closed Skyline Drive in Virginia and evacuated visitors, ham radio carried a part of the message. Hams also assisted in the pullout of over a half-million tourists and residents ordered to evacuate the coast in North and South Carolina. More than 19,000 people packed shelters overnight, shelters

manned by volunteer workers, side by side with ham radio communicators.

Earlier in the day hams were put on alert as Hurricane Fran approached the southeastern coast. Much of the activity was on 75-meter SSB with South Carolina ARRL section manager Mike Epstein, KD1DS, activating an ARES and RACES net with the state SSB net working as a backup. The Georgia state emergency SSB net was on 3.975 kHz while the Virginia state emergency nets held forth on 3.910 kHz and 3.947 kHz, respectively.

Jerry Herman, N3BDW, reports that the Hurricane Watch Net was activated on 140325 MHz in coordination with the National Hurricane Center station, W4EHW, in Miami as the storm approached.

One of the big casualties of Fran has been cellular telephones. In reality, cellular telephones are nothing more than a radio link to the wired the wired telephone network. When the wires come tumbling down everyone tries to use their cellular phones. The remaining lines get overloaded and service goes away. That's where Amateur Radio takes over. (Bold - ed.)

Regarding the National Weather Service, many hams put themselves at risk to keep their communities and the NWS informed of Fran's devastation on a local level.

and Order in the FCC's RF safety Docket 93.62. The League will claim that the data used in formulating the new rules was flawed and therefore the action taken to create the rules is arbitrary and shortsighted.

TECH TIP #1

Is that old piece of coax any good? One way to check is to bend the coax into a small loop. If it doesn't spring back, it's possible the insulation has deteriorated, and should be thrown out. (This won't work with hardline!!!)

TECH TIP #2

GROUND THAT TRIPOD! If you are using a tripod for a mast or vertical antenna on your roof, be sure to run a ground wire from the tripod to the electrical ground you use below. You want to reduce any chance of potential electrical buildup.





HCRA AUCTION RULES

- Items must be electronic or PC related. No non-working TVs please.
- All items must be marked with the Call or first and last name if not a ham, of the seller
- If the seller is not present, the call of the person bringing the item should be clearly marked.
- The HCRA retains 10% of the selling price up to a maximum of \$10. This means that if you sell an item for \$300 the HCRA only keeps \$10.
- Minimums are allowed but must be clearly marked on the item(s).
- You may bid on your own item, but if you win, you must pay the club the 10%.
- The Auctioneer has the right to combine items in the interest of time.
- All equipment, boxes, junk, etc. must be removed from the premises. No disposal facilities are available at the church.
- Doors will be open at 7:00 pm for the those selling in the auction. The equipment will be lined up and auctioned off in the order in which it was brought in the hall. If you wish to leave early, bring your stuff in early!
- Minimum increment will be 25 cents unless changed by the Auctioneer.
- Donations to the club will be happily accepted, but please be sure to clearly mark them!
- No disbursements of funds will be done until the auction is finished. You may request that a check be sent to you.
- The decision of the Auctioneer is final!


