URGENT

The FCC issued a Notice of Proposed Rulemaking (NPRM) to lop off the bottom two megahertz of the 220 band exclusively for the land mobile service! One wonders why such a proposal would be made only after the allocation of 220 for new Novice privileges!

The FCC issued the NPRM, numbered General Docket 87-14, in response to three petitions filed by land mobile service users. The FCC stated that the 220 MHz band was "underutilized" in comparison with the two meter band.

Even if you have never utilized this spectrum, and never intend to, it is VERY IMPORTANT that you let the FCC know that reallocation of valued (yes, there are lots of 220 users out there) Amateur frequencies will not occur without a fight.

Please take a minute to put your thoughts down on the enclosed page. It is ready to mail to the FCC. If you have access to a copy machine, make FIVE ADDITIONAL copies, and send them all to the address on the form.

In your own words please indicate why you do not support the FCC's action. Even if you only write two sentences the fact that you sent comments will make a difference. Contacting Congressmen and Representatives will also help!.....

Your comments are due to the FCC by April 6, 1987 (although this is expected to be extended). Please invest 22¢ and a few minutes today... tomorrow it may be your favorite band!



Illegal cordiess telephones: The FCC has ordered a California retailer to stop selling high-powered cordless telephones that lack FCC certification and has fined the company and the phones' manufacturer \$2,000 each. The Super Call 7700 cordless telephone has a range of about 60 kilometers, in contrast with a range of 200 meters for most approved cordless phones. The Super Call base transmitter uses ten radio channels in the range 46.610 to 46.970 MHz, while the handset uses the 66,000 to 72,000 MHz range. The base unit runs 15 watts and the handset runs 5 watts!

Ham bytes robot: During the Christmas shopping season, the police responded to the burglar alarm at the Radio Shack store in South Dennis, MA. Upon entering the store, they found a robot busily moving about inside the store. It seems that the Radio Shack robot's receiver is on 49 MHz, and it was being activated by the transmissions of the near-by W2CAP/1 six meter beacon! Do you suppose that the robot can copy CW? The store employees were more careful to turn off the robot when leaving the store for the night after that!

432 MHz Activity Promotion: Art Holms, WA2TIF, writes: "I think that 432 can become an every night band with a little push. I hope these awards that I am sponsoring will do the trick. Please publish in your newsletter and elicit support from the members. Once 432 reaches the status of 144 MHz, it will be much easier to get activity on the higher bands. I am rounding up "seed" stations to help get it going. At the moment I have K8ZES/2, VE2DFO, WA2TIF, K1DPP, W2CRS, KB3IB, and N3ADC. I could use some more help in New England!"

432 Activity awards. The purpose is to promote 432 MHz activity each night. The ground rules are: 432 MHz SSB or CW QSO's only; start 01-Dec-1986; contest QSO's do not count; net QSO's do not count; QSY off the calling frequency of 432.100 MHz; send copy of your log for verification (include date, call, and grid square). The QSO award

will be issued for 50 QSO's per month; separate award for each month. The Station award is given for working 100 different stations (no time limit); update for multiples of 100 stations. The QSO X Grid award is isued for the number of QSO's times the number of unique grid squares worked each month, minimum of 1,000 points (i.e. 50 QSO's X 20 grids). The sponsor and mailing address appear below. Send log data and a business size SASE for awards.

In the past couple of months the activity seems to start about 7:30 or 8:00 PM local and ends somewhere about 10:00 to 10:30 PM local. There has been quite a bit of activity each night. Look to the northeast especially! Bernie, VE1UT, in FN63 is on at 9:00 PM local every night, and will be looking for you!

Preamp

Tower Mounted Preamp Control by Fred Stefanik N1DPM

In an effort over the past four to five years to perfect my tower mounted GaAs Fet preamps, I've arrived safely at this system. First, this only applies to those of us running transverters or that are capable of utilizing the "two feedline system." Also the unit has self-contained power supplies, and is capable of handling up to six bands worth of preamps! All the parts for this unit are available at your local Radio Shack store at a minimal cost, in comparison to a couple or even one blown preamp. The coax relays used should be high quality with enough isolation so that the preamp doesn't get damaged. Proper minimum isolation is shown in the table below. Two relays could be put back to back for increased isolation, with the coils wired in series or parralell.

A new net has been formed on the 10 meter band. Check in on Sunday evenings at 7 PM local time. The frequency is 28.400 MHz upper side band (USB). Rusty KB1XD is the net manager. Novices & Techs are welcome!

To insure trouble free operation the coax relay coils should have diodes installed across them to prevent turn-off transients. This unit, along with controlling the tower preamps and T-R relays, also provides sequentially switched outputs for the R-L make on your transverter, intermediate amplifier and your high power amplifier, with a standby or operate switch or swtiches fo rthe amplifiers.

I have successfully used this system on three bands: 144, 220 and 432 MHz for about one year. Semi-breakin CW operation is safe because of the proper sequencing, even at 1.5 KW! Good luck with the new tower preamp and see you on the bands! 73 de Fred N1DPM






