#### 1988 VHF Sweeps

Its January again and that means its time for the annual running of the January VHF Sweepstakes contest. The next HCRA meeting will be dedicated to the VHF Sweepstakes. In addition, you'll note that this issue of ZERO BEAT is jam full of useful things for your participation in the 1988 January VHF Sweepstakes.

To continue the HCRA's tradation, we are looking for your support in the January 1988 contest. So dig out that seldom used equipment and make plans to be on the air the weekend of January 23<sup>rd</sup> through the 25<sup>th</sup>, 1988.

#### W1NY Activity

The HCRA club station W1NY will be again active on all bands throughout the contest. The W1NY operators would sincerely appreciate a contact from you to boost their score. Last year we had our best club effort ever! We hope that we will again set a new record in 1988!

If you are interested in participating in the W1NY effort, we'd be glad to hear from you. Please contact and of the following club members: Art W1KK, Fred N1DPM, John AC1T, or Frank NC1I.

#### Club Competition

Only the January VHF contest has the aggregate club entry. All HCRA members are urged to submit a log, even if you only work two contacts, to the ARRL to help with our club score!

Participation in this contest is easy and fun. QSO as many stations as you can on as many bands as you have equipment for (of course, 6m and above). Even if all you have is a pair of HT's: one for 2m and one for 70cm, you can work lots of people!

If you don't like contesting you can still help in our effort to take first place nationally! Last year we came close, surely with your support this year we have a good chance! If you spend a few minutes or even an hour on the air giving out contacts it will help increase the scores of those who are logging for contest points.

#### **Contest Details**

If you have the time to log your QSO's you can help with our combined club score by sending in your logs — its that simple! Now for the details:

The contest starts at 1900 UTC on Saturday January 23, 1988. For those of you who don't usually deal with UTC (GMT) that's 2PM local time. The contest runs through 0400 UTC Monday January 25, 1988, which is really Sunday night at 11PM. There are many national and local activity times during the contest. See the complete list in this month's ZERO BEAT!

#### Exchange

This has to be the easiest contest for exchanges. All you have to pass along is your grid square. For those of us who reside in Western Massachusetts the grid square is FN32. To the south in CT the grid square is FN31. The exchange of signal reports is optional. So using any voice mode you may say: fox november thirty-two. And on CW it would be: well, its pretty hard to do on paper, but you know!

Hopefully you can log your contacts, and turn in your score for inclusion with the club's effort. Included in this issue of ZEROBEAT is a log sheet. You only have to write the date and band info when it changes. For each contact jot down the time, the call of the station you worked, and the grid square of the other station. The Mult column can be used to keep track of those QSO's where you work a new grid square. And the small column with no heading can be used to check for duplicates. Of course, at the top of each page you would fill in the boxes with your call, your grid square, and sequentially number your log sheets. This log page also has some free space to the right (called notes) where you can scribble notes!

#### Summary Form

When the contest is through you should fill out the VHF Sweepstakes form, also included in this issue of ZEROBEAT. As with the log sheets,

indicate your call, grid square, and ARRL section in the boxes at the top of the form. Then check which station category you fall into: most of you will check the single operator station category, and if you work more than one band, the multiple band selection.

Then count the number of QSO's you made on each band and fill in the boxes in the QSO's column. As you can see, the higher in frequency the more points a contact is worth. Compute the QSO points by multiplying the QSOs times the multiplier on the form. Then count the number of different grid squares you worked for each band, and fill in the boxes in the grid<sup>2</sup> mult column. Finally compute your score for each band you worked by multiplying the QSO points by the grid squares.

Then figure your total score: this is what counts! Add up all the numbers in the following columns: QSO's, QSO Points, and Grid<sup>2</sup> Mult. Then multiply the Total QSO Points by the Total Grid<sup>2</sup> Mult to get your Total Score! (Note: Your Total Score will not equal the total of your band scores, so be carefull!)

And of course, sign and date the form, fill in your return address (you may win an award!), and note any comments about the contest on the reverse side.

#### Don't Delay!

All entries to the League must be postmarked no later than 30 days after the end of the contest. So if you make an effort to log your contacts please don't forget to send in the materials!

You have two choices on submitting your logs. If you have no problems filling out the summary

form you should send it directly to the League. If you have any problems or questions please mail them to the club mailing address: PO Box 482, West Springfield, MA 01090-0482. We will forward your logs to the League after we check them for accuracy. Its easy!!

#### W200NY via KA1KPH

# FCC & ARRL authorize HCRA for W200NY

The HCRA has received approval for the operation of its club station W1NY during the special Amateur Radio Celebration of the Bicentennial of the United States Constitution. Bob KA1KPH, who is coordinating this special event, received written permission from ARRL Executive Vice President Save Sumner, K1ZZ, just prior to Christmas.

"On instructions from the FCC, the Hampden County Radio Association, is hereby authorized to operate [its club] station W200NY during the week of February 6 - 12, 1988 (from 0001 UTC Saturday through 2359 UTC Friday). This action is pursuant to the FCC Order of July 9, 1987, "Waiver of Section 97.84(a) to allow designated club stations to identify using a special 200 call sign," and FCC authority letter 7230-D. dated November 17. 1987.

"Details for the Bicentennial of the U.S. Constitution celebration can be found on pp. 14-16, September 1987 OST."

ARRL Secretary Perry Williams W1UED requested a waiver of the station identification requirement regulations of the amateur service rules to allow a limited number of designated amateur club stations to be authorized to use a special commemorative amateur call sign for the bicentennial. The FCC supported this request, noting that "the use of a special bicentennial call sign will enhance and highlight the operating aspects of the project... The ARRL believes that the use of a special commemorative call sign would enable amateur operators to recognize the significance of the bicentennial and encourage radio contact with the designated club stations during the celebration."

The FCC went on further to say "We believe that the ARRL's request has merit and is in keeping with our statutory mandate to encourage the larger and more effective use of radio in the public interest. Accordingly, the ARRL's request for a waiver of Section 97.84(a) is granted..."

A limited number of clubs all over the country have been approved to operate for one week using a special 200 callsign. The HCRA is proud to be one of the authorized clubs to participate in this program.

A complete list of states and operating dates can be found on pp 15 of September 1987 <u>OST</u>. Many states have already had their operations; maybe you've worked one or more of the special events stations. The rest will continue through December of 1988.

Plans are now underway for the HCRA W200NY operation in February. A special QSL card will be made available to anyone who works W200NY. Multi-mode operation on HF and even VHF/UHF operation is planned. As this issue of ZERO BEAT goes together exact plans have not been made, as the approval was only recently received. The operation may partially take place in one or more public places.

It is desired to attempt to operate W200NY two shifts each day the authorization is in effect. Thus we are looking for individuals to operate during the daytime as well as evening hours. Club members with Amateur Extra class licenses are also

needed for control op duties. Station operators (any license class) are also needed. If you have any interest in operating special modes, I'd like to hear from you, too.

Please see me during the January HCRA meeting, or write to me at my mailing address: KA1KPH, Box 17, Feeding Hills, MA 01030. My work schedule makes it difficult to be reached by phone, so the next club meeting or via mail is the best way to get intouch.

W200NY QSL's will be via KA1KPH, at the above address, with an SASE, please!

#### **Contest Aids**

Specially designed logs, contest forms, and a grid square map is included in this issue of ZEROBEAT for your contesting pleasure. We hope that you have time to get on the air and rack up points for the club.

There is also a table of activity times that may help in planning your operating time. The national activity hours are valuable for single operator stations who want to make the most of a multi-band operation. Most of this activity occurs on SSB and CW, although many of the larger contest stations will also be readily available on FM during these times.

The local activity hours have been called FM activity hours; in this way the majority of the HCRA members who only have FM equipment can participate in the contest and rack up loads of points. These periods have been designed not to conflict with other contest operating events, local nets, etc and other activities.


